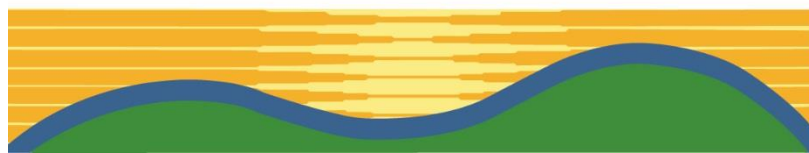

SUMMARY

The 2018-2019 Draft Budget and Strategic Resource Plan (SRP) 2019-2022 submissions closed on 23 May 2018. Council have been provided a copy of all submissions and this report provides a summary.

RECOMMENDATION

THAT Council accept the submissions to the 2018-2019 Draft Budget and Strategic Resource Plan 2019-2022 and officers prepare a report for the Council meeting to be held on 25 June 2018.

REPORT

Twenty-three submissions were received relating directly to the 2018-2019 Draft Budget and SRP 2019-2022. Copies of all submissions have been previously provided for Council review. Of these submissions, one was received after the closing deadline. Nine parties are expected to present their submission in person to Council and up to nine other parties may attend.

Officers have reviewed all submissions and provided initial information to Council in a document circulated separately.
