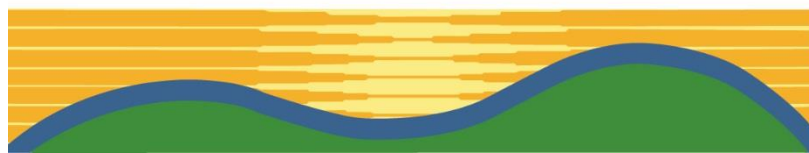

#### SUMMARY

The 2019-2020 Draft Budget and Strategic Resource Plan (SRP) 2020-2023 submissions closed on 22 May 2019. Council have been provided a copy of all submissions and this report provides a summary.

#### RECOMMENDATION

#### REPORT
