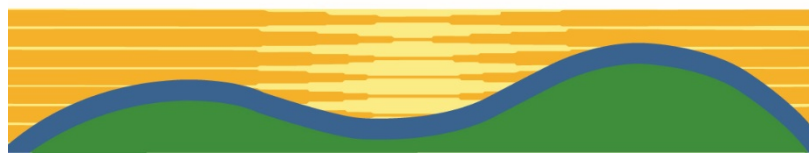

#### SUMMARY

The 2020-2021 Draft Budget and Strategic Resource Plan (SRP) 2021-2024 submissions closed on 22 April 2020. Council have been provided a copy of all submissions and this report provides a summary.

#### RECOMMENDATION
