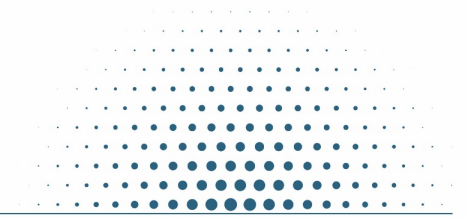

Section 5 – Conditions applicable to all permits

- > Approval depends, to a large extent, on the attitude of the neighbours
- > Runs, yards, pens, sheds and kennels etc will need to meet applicable code of practice or to the satisfaction of a Council Officer
- > Failure to maintain conditions, or the receipt of complaints from neighbours, could result in termination of permit
- > The attached neighbour support form has to be completed by abutting neighbours and submitted to Council as per mailing address
- > All applications are subject to an inspection by an authorised officer
- > The application fee is non-refundable



Section 6 – Conditions specific to cat/dog permits

- > All dogs and cats on the property must be registered with Mitchell Shire Council
- > All dogs must be under control or confined to your property at all times
- > The permit is only applicable to the original animals, ie. if any of the extra dogs/cats pass away, they must not be replaced
- > All applications are subject to an inspection by an authorised officer
- > Once a permit is granted for a specific number of dogs/cats, no further increases in number will be allowed (ie. If you have a permit for four cats, you must not acquire a fifth animal without written consent from the Local Laws Department)

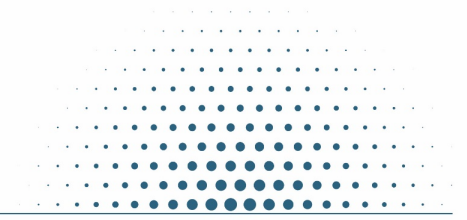
