## State Government Levy

A State Government levy of \$4.16 for every dog and cat is included in your pet's registration fee. This levy is primarily used to fund responsible pet ownership educational programs.

## Concession

For persons eligible under the *State Concessions Act 2004* (Pension card concession card, War Widow entitlements or TPI entitlements), a 50% concession rate applies for both maximum and reduced fees unless specified. **This does not include Health Care Card holders. Please present your card to receive this concession.**

Please note that concession rates are not applicable to declared dangerous dogs.

## Declared Dogs

If Council declares a dog to be dangerous or menacing there are certain rules that must be complied with in accordance with the Regulations under the *Domestic Animals Act 1994*. More information can be found at [www.mitchellshire.vic.gov.au](http://www.mitchellshire.vic.gov.au)

## Working Dog Status

To be eligible for a reduced registration fee you must be a primary producer, or contracted by a primary producer and your dog is a working farm dog.

Working farm dog is defined as a dog usually kept on rural land, by a primary producer or a person employed by a primary producer and primarily kept or trained for the purpose of droving, protecting, tending or working livestock on a farm.

## Applicable organisations

To receive a reduced registration rate for their animal, the owner of the animal needs to be a member of one of the applicable organisations with which the animal is also registered.

1. Australian National Cats Inc
2. Dogs Victoria
3. Feline Control Council (Victoria) Inc
4. The Governing Council of the Cat Fancy Australia and Victoria Inc
5. Master Dog Breeders and Associates
6. Responsible Pet Breeders Australia

## Dogs under 12 months of age

Council will provide an initial discounted registration fee for dogs under 12 months of age that are not de-sexed (no concession available) proof of de-sexing must be provided prior to the following years registration.

## Approved dog obedience training

There are four organisations whose qualified trainers can issue certificates that entitle you to a discounted registration fee:

3. Four Paws K9 Training
4. Kintala Dog Club Association Inc
