Wish to apply for a permit to collect firewood on roadsides.

APPLICATION MUST INCLUDE:

- Completed and signed application form including indemnity in favour of Mitchell Shire Council.
- Application fee of \$20.00
- Certificate of Currency showing that applicant is covered for a minimum of \$20 million legal/public liability insurance. The certificate must show currency and if it doesn't list the public liability then a copy of the insurance policy PDS must be included.

CONDITIONS

1. Produce this Permit on demand to a Police Officer or Authorised Officer of the Mitchell Shire Council.
2. Mitchell Shire Council reserves the right to stipulate the roads and sections of road that firewood can be collected from and this may be reduced from the standard approved roads at any time.
3. Firewood is only to be collected from roads approved and detailed on the firewood Locality Collection maps available from www.mitchellshire.vic.gov.au
4. Only persons over the age of 18 are permitted to collect firewood on Council roadsides.

5. The area is to be left in a clean and tidy condition. e.g. take all personal litter with you.
6. Chainsaws must be fitted with a proper exhaust and spark arrester.
7. Chainsaws are only to be refuelled or filled with oil on an impermeable surface.
8. This permit does not allow for the felling of timber and no damage is to be done to any fences, standing trees, roadside drainage or other Council Assets.
9. The permit holder must only stop a vehicle in use under this permit in an area off the main part of the road carriageway and in accordance with any road rules.
10. Heavy Vehicles (>4.5tonne GVM, including any trailer) must not be used to collect firewood from roadsides.
11. The collection of fallen timber must be in accordance with the *Road Management Act 2004*, *Mitchell Shire Council Road Management Plan*, and the *Mitchell Shire Rural Roadside Code of Practice* and any other Act or Regulation relating to this activity.
12. Heavy machinery (e.g. log splitter, saw bench, tractor) must not be used for firewood collection.
13. Fallen or felled trees must not be towed or winched along the ground
14. Do not collect or remove fallen or felled trees that are visibly hollow or growing moss or fungi with a coverage of >50%
15. Fallen timber is for personal use only and cannot be sold.
16. Roadside firewood collection is prohibited during the North Central Fire Danger Period.
17. This permit allows the collection of 1 cubic metre in total of fallen firewood only.
18. An individual or partnership will be granted up to 3 permits during one firewood collection season only.
19. The Permit is not valid on days of Total Fire Ban as declared from time to time by the **Country Fire Authority** for the North Central Total Fire Ban Region.

Expiry of permit

- Permits are valid for 7 (seven) days.

Safety

- Avoid collecting firewood when conditions are wet, windy or hot
- Assess your work area for hazards before you commence your work
- Avoid working near hazards
- Avoid working alone or with children (children under 18 are not permitted to collect firewood)

- Be trained and competent in the use of firewood collection equipment, including chainsaws and use well maintained equipment

Hazards

Hazards found in designated firewood collection areas may include, but are not limited to:

- Broken overhead branches, dead standing trees
- Uneven or slippery ground conditions
- Vehicles
- Mine shafts
- Snakes and stinging insects

Other Requirements

- Failure to fully provide the required information will result in my application being returned and a delay in processing.
- The applicant understands that the personal information provided is to assess your application and record your permit and that he or she may apply to Council for access to and/or amendment of the information. Requests for access and or correction should be made to the Local Laws Department.
- I agree to indemnify and to keep indemnified Mitchell Shire Council, its servants and agents (the Council), from and against all actions, costs, claims, charges, expenses, penalties, demands and damages whatsoever which may be brought or made or claimed against them, or any of them, in connection with the collection of firewood under this permit.
