Your application must include:

- **\$60** application fee. (non-refundable if permit refused)
\$10 application fee applies if the applicant demonstrates that the grazing of the roadside is for the purpose of fire prevention. You must provide a written explanation of this.
- Provide a map of road in which grazing will be undertaken
- A copy of Public Liability Policy of at least \$10 million dollars.

Conditions:

- The owner is responsible to ensure confinement of livestock, whilst minimising hazards to persons, animals and property.
- Appropriate precautions are taken to ensure that no damage occurs to road surfaces, furniture, drains, culverts, bridges and private entrance ways or to trees and shrubs growing within the road reserve and that erosion is not caused by excessive grazing. In the event that livestock are causing damage including where overgrazing occurs, they are removed from the road reserve.
- The livestock can be adequately fed and watered on the road reserve.
- Signs conforming with guidelines prepared by VicRoads and referred to in the *Road Safety Road Rules 2009* are in place.

- Permit Holder is to observe and comply with the *Livestock Disease Control Act 1994* and the *Prevention of Cruelty to Animals Act 1986* and any other Acts and Regulations relating to this activity.
- Failure to comply with any of the above conditions could result in this permit being cancelled and/or penalties as prescribed in the Local Law.

PUBLIC NOTIFICATION

I understand that, as part of the Permit Application process, Council will contact in writing, any properties affected by my application.

Any objections received by Council, in writing, within 14 days of receipt of this communication may affect conditions placed on the permit, or the outcome of it being granted.
